ADULT LEAGUE CODE OF CONDUCT

The purpose of the Code of Conduct, applicable to every participant and spectator, is to promote good sportsmanship, proper conduct on and off the court/field, and to fully comply with the rules and policies of the Martinsburg-Berkeley County Parks & Recreation Board.

All participants will be expected to carefully review the rules and requirements set forth and are solely responsible for their actions, both on and off the playing court/field. Improper behavior can, and will, directly affect the future participation of the individual's entire team.

The "Adult League Code of Conduct" applies to all adult participants (players, managers, coaches, etc...) This code applies to any individual or team and the penalties can be applied to any individual or an entire team. **This code becomes effective as soon as the participants arrive at the facility of play and remains in effect until the participants leave the facility.**

It is the responsibility of the team captain, team manager or coach to see that all team members have been provided a copy of these rules. The signature by the team captain, team manager or coach, at the bottom of this page serves as acknowledgement of the following code of conduct. Furthermore, the signature indicates that all team members are aware of and have been provided a copy of the following code of conduct.

NO PARTICIPANT SHALL:

1. At any time lay hand upon, push, shove, strike, or threaten an official or employee of the Martinsburg-Berkeley County Parks & Recreation Board.
2. Endanger the safety of any player, official, employee, or spectator.
3. Refuse to abide by an official's decision
4. Use personal or verbal abuse toward any official or employee of the Martinsburg-Berkeley County Parks & Recreation Board.
5. Use unnecessary rough tactics in the play of the game against another opponent.
6. Demonstrate objectionable behavior or dissent at an official's decision.
7. Discuss with an official, in any manner, the decision reached by such officials. (Exception: Team Manager)
8. Discuss publicly, with spectators or team members, in a derogatory manner any play, decision, or personal opinion of other players in the game.
9. Play under another individual's name, falsify name, or falsify age or address on an official roster.
10. Play on more than one team.
11. Appear at the facility in an intoxicated condition.
12. Attempt to incite riot among his/her team or among the spectators.
13. Destroy, deface or disrespect park facilities, fields, equipment or facility amenities.
